

The Groundwater Section of the Arizona Department of Environmental Quality (ADEQ) has received your Notification of Intent (NOI) to discharge under a Type 2.02 General Aquifer Protection Permit for an Intermediate Stockpile.

ADEQ received the NOI on August 30, 2011 for the discharging facility described as the Development Rock Stockpile - 36° 30' 10.7" North and 112° 43' 57.6" West. ADEQ's findings are as follows:

- The permittee **IS AUTHORIZED** to operate the development rock stockpile at the location specified in the NOI under the terms of the general permit. The NOI and supplemental documentation satisfy the requirements in Arizona Administrative Code (A.A.C.) R18-9-C302 and R18-9-A301(B). The authorization is recorded as **P-100300**. The permittee shall comply with all design, installation, operation, monitoring, record keeping, reporting and closure requirements specified in A.A.C. R18-9-C302, and also with all other applicable requirements of 49 A.R.S. 2, and 18 A.A.C. 9, Article 3. The renewal date for this authorization is **FIVE (5) YEARS** from the date ADEQ received your NOI, or **AUGUST 30, 2016**. If an NOI is not submitted at least 30 days prior to this date, the authorization to discharge will expire.

This authorization can be revoked and an individual permit required in the event the permittee fails to comply with the terms of the general permit described in the rules, or if the discharge activity causes or contributes to or has the potential to cause or contribute to the violation of an Aquifer Water Quality Standard at the applicable point of compliance.



The renewal date for this authorization is **FIVE (5) YEARS** from the date ADEQ received your NOI, or **AUGUST 30, 2016**. If an NOI is not submitted at least 30 days prior to this date, the authorization to discharge will expire.
