



**APPLICATION FOR OUT OF STATE VEHICLE EXEMPTION  
 ARIZONA CAR CARE PROGRAM  
 ARIZONA DEPARTMENT OF ENVIRONMENTAL QUALITY  
 (For vehicles registered in Metro Phoenix Only)**

If your vehicle will be out of the State of Arizona longer than 90 days before your registration expires, you may qualify for an out of state exemption. To apply, you must do one of the following (as applicable):

- 1) If the vehicle is located in an area that **has** an emissions inspection program, you must have the vehicle tested there and submit a **passing** Vehicle Inspection Report (**original, not a copy**); or
- 2) If the vehicle is located in an area that **does not** have emissions inspection program, or does not perform inspections on the vehicle described below, you must complete the **Affidavit** portion of this form and have the **Out-Of-State Verification** portion of this form completed by a local law enforcement official or Department of Motor Vehicles official. This form must be completely filled out. The vehicle must be emissions inspected within 15 days of returning to Arizona. After passing the inspection, please retain the Arizona Vehicle Inspection Report (VIR) as proof your vehicle is in compliance with Arizona emissions requirements.

**NOTE:** Out of State Exemptions are issued for a period of one year only.

Send this **original** application when completed or a passing VIR (if applicable) along with the **\$9.50** out of state exemption fee (check/money order payable to ADEQ and have the imprinted name and physical address of the customer – **no post office boxes**), a **copy** of the Arizona registration renewal form, and a self-addressed/stamped envelope to:

When approved, an out of state exemption certificate will be sent to you. Include the certificate with the vehicle registration renewal, and mail to the Motor Vehicle Division.
